. Re visit to Michael Ferguson, in general, he supported the campaign idea. The following matters were raised/discussed.

.... Increase Motorcycle L and P Riders speed limits in line with Motor Vehicle drivers at same level.

.... Possibility of getting funding from the State Government.

.... The fact that the Tasmania Road Safety Advisory Council did not support funding.

.... Lack of decision making by the Transport Department.

.... Lack of Support for TMC by MAIB and Government.

.... It was put to the Minister that he put a pool of monies aside for TMC to the value of \$20K for the Government to audit and pay accounts as raised.

.... It was raised that the Tasmania Road Safety Advisory Council had sponsored the NWC footy league (with a target audience of 17 to 24) but not us!

.... Michael was invited to the launch of the new Indoor training facility done by AJL.

.... Michael advised by TMC that we intended to run our own campaign re Ride to Live - but this was before we were made aware of Royalties!

. As a result of the Royalties associated with the NSW campaign, Simon looked at the RSAC adverts. From this Simon wrote to Michael Ferguson again and suggested we could cut down the RSAC L plate version adverts to 30 seconds and have a campaign run April and May.

. Julie mentioned that we need more awareness Promotion for car drivers as well.

. Paul to send links to adverts to all TMC members via email.

. Danny pointed out that the audit on Hollow Tree Rd was done just last year and he went thru there last week and noted signs in place.
